The book also deepens the analysis of the market behavior of the public buyer from a competition perspective. Proceeding through a careful assessment of the general rules of competition and public procurement, the book constantly tests the efficacy of these rules against a standard of the proper functioning of undistorted competition in the market for public procurement. It traces the increasing relevance of competition considerations in the case law of the Court of Justice of the EU and sets out criteria and recommendations to continue influencing the development of EU economic law.
